What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: Social Security number and income Account balances and credit history Assets and account transactions

What we do			
How does AgilLink protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards, secured files and secured buildings.		
How does AgilLink collect my personal information?	 We collect your personal information, for example, when you: Open an account. Use your credit card or debit card. We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. 		
Why can't I limit all sharing?	 Federal law gives you the right to limit only: Sharing for affiliates' everyday business purposes - information about your creditworthiness. Affiliates from using your information to market to you. Sharing for nonaffiliates to market to you. State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law. 		
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.
