Interest Rates and Interest Charges

APR for Cash Advances	29.25% This APR will vary with the market based on the Prime Rate.*
How to Avoid Paying Interest on Purchases	Your due date is at least 25 days after the close of each billing cycle. We will not charge you any interest on purchases if you pay your entire balance by the due date each month.
Minimum Interest Charge	If you are charged interest, the charge will be no less than \$0.70.

The Prime Rate current within the last 30 days is 7.50%. We add a margin of either 15.75% or 19.75% to the Prime Rate to determine the APR for Purchases and Balance Transfers, based on your creditworthiness. We add a margin of 21.75% to the Prime Rate to determine the APR for Cash Advances.
